Bidders must submit their proposals on the official Municipal bidding documents, which will be available at the Municipal offices, located at **P711 ROAD, LOT 152, Maphumulo** from **Thursday 18 March 2021 and 19 March 2021 ONLY**. A non-refundable document fee of R200.00 is payable upon collection and payment must be deposited on **ABSA Bank**, account number: **4056102866**.

Proposals in an enveloped marked **"REVIEWING, COMPILING AND PRINTING OF 2019/20 ANNUAL REPORT"** shall be deposited into the tender box at: **Maphumulo Municipal Offices, P 711 Road, LOT 152, Maphumulo** no later than **12H00 Thursday 25 March 2021** where they will be opened in the public. **Late, Telegraphic, faxed or posted tenders will not be accepted**. Bidders must submit the following **mandatory returnable documents** in order to be considered for this bid:

- Printed Copy of valid tax clearance **PIN** for further verification.
- **Certified ID(s) copies** of company director(s) (**Not older than 3 months**)
- **Certified Copy** of company registration (**Not older than 3 months**)
- **Proof of payment** for tender document
- Company municipal rates, electricity or water account (**Not older than 3 Months**), proof of Residential lease or rental or sworn affidavit accompanied by proof of residence if the business operates at a place of residence.
- Completed and signed Municipal Bidding Document attached in the tender document.
- Registered on Central Supplier database (CSD).

Evaluation will be done on the following two-stage process in terms of National Treasury Circular No: 53

Stage 1:

Evaluation of functionality in terms of MFMA Circular 53. Only the service providers who achieve a minimum of 60% or 60 points of the total points will qualify for stage two of the Evaluation process.

The points for stage one will be allocated as follows:

Methodology	30
Local Economic Development	10
Lead Time	10
Availability of Resources	20
Total	100

Stage 2:

The 80/20 preferential point system will be applied, where 80 points will be allocated for price and 20 points for B-BBEE Status. Bidders are encouraged to submit an original or certified copy of B-BBEE certificate issued by SANAS Accredited Verification Agency. In case of EMEs bidder may submit an original SWORN Affidavit signed by a commissioner of oaths to claim Preference Points.
